- b) January 12 held the SDAB hearing for the Felzien bin yard permit and decision is expected approx. late January within 15 days
- c) DO T. Pawsey gave the board a review sheet with questions for potential update to the LUB regarding dugouts. Consensus from the Board was that dugouts should be defined as the hole being minimum 75' from centerline of road, berm not to be used to determine setbacks. Intersections should reflect 125' from centers of roads, and roadside sloughs being deepened are not dugouts however should come to MPC for development conditions. The process to review existing dugouts and field bins for variances if needed should not include an application fee and they be treated as separate cases for each situation.

- 3) The dugout shall conform to all other municipal, provincial, or federal regulations and guidelines per Section 8 1. (c) of the LUB No. 698-21.
