



## Community Benefit Fund Application Paintearth Wind Project

In 2024, the Paintearth Wind Project entered into an agreement with the County of Paintearth to establish a Community Benefit fund that would allocate a maximum of \$15,000 annually to be distributed through an application process for educational programs and STEM based scholarships.

### **Educational Allocation (maximum of \$15,000 annually):**

Program Funding through the Community Benefit fund is available to County of Paintearth based educational projects or programs that enhance and enrich our community in one of more of the following categories:

- ❖ Environmental Education – projects or programs that focus on the environment, reduce environmental degradation, or increase community awareness of environment issues.

Scholarship Funding through the Community Benefit fund is available to County of Paintearth high school graduates who are enrolled in and attending qualified post secondary colleges or universities ideally in the field of:

- ❖ STEM – Science, Technology, Engineering or Mathematics

Community Fee Assistance Program Funding are available to Organizations that provide assistance to eligible individuals to access community recreation, arts and leisure programs. In the Paintearth region these funds will be administered through organizations such as KidSport or FCSS.

### **Eligibility**

- ❖ Local schools, and other individuals and groups as deemed appropriate.
- ❖ Graduating High School students from schools within the County of Paintearth

### **Approval Criteria**

- ❖ All applicants are required to submit an application letter with details of the program – see attached.
- ❖ Scholarship students are required to submit an application outlining why they chose their program
